President's Report

Central Wisconsin Christian 23/24 school year has been an exciting, busy and rewarding time for the board. We are grateful for God's guiding hand through it all as we navigate through the many new changes, and look to the future of CWC. It is great to see our school community thrive and to be a part of our school board where so many members are working towards the same common goals. I would like to highlight a few of the larger items we as a board worked on over the past year.

The first being the hiring of our new Head of School for the 24/25 school year. Mark has done a fantastic job for the last 14 years and we knew he would be hard to replace. The search team put in countless hours last fall looking for our next leader, and by November had the candidates narrowed to two. Dr. Chris Gann stood out all along the interview process. When he came to visit in person the search team and board knew that he was the man God was calling to be our next Head of School. We unanimously voted for him and we are confident in his abilities to lead us for years to come. We are excited for his arrival in late June and excited to see God use him at CWC.

Another topic over the past year has been the continued growth of CWC. The word is out and interest in our school continues to grow. Our enrollment for next year will conservatively be around 530 students. This continued growth prompted the board to look at class sizes and limitations. Through much research and discussion, we have approved a class size cap of 22 students for grades K-2, 24 students for grades 3-5, and 25 students for grades 6-12. The formation of class size caps inevitably leads to waiting lists for certain grades. In order to deal with the issues that arise in choosing what students fill the appropriate spots in their grade, the board has formed an admission team. They also approved a matrix system with points that will help guide them in the decision making process.

The final board action I would like to touch on is the approval of starting an after school care program. This has been a topic that has been talked about for many years and thanks to the work of the Education Committee is finally going to be put into action. This program will provide care for children K-5 in a controlled environment, and give parents the assurance their children are being well taken care of while they are at work. We know this will be a blessing to many families and add value to the CWC experience.

Christian education is truly a gift from God. I would like to thank all the members of our board, our teachers, and staff for the time and work they all put into making CWC what it is today. God has blessed us for many years and we pray for His guiding hand for generations to come.

2024/25 Budget Narrative

CWC's operating funds are in great shape as we near the end of the 2023-24 school year. With three months remaining, we expect to finish the year with a budget surplus. The Finance Committee, thanks especially to the efforts of Head of School Mark Buteyn and Business Manager Lexy Medema, has prepared a budget for the 2024-25 school year that accommodates 502.5 full-time equivalent students – a full 100 more than where we finished the 2022-23 school year.

The proposed budget reflects an increased tuition rate of 2.5% across the multi-child tuition grid. It also provides a range of annual compensation increase to the teaching and support staff of 2.9-5.1%. Bargains Galore Thrift Store, the Harvest Auction, and donations received via the Sharing the Promise and Giving Tuesday efforts are budgeted to contribute more than \$650,000 to the operating budget.

Current Legacy Project debt totals slightly more than \$7.1 million. The majority of this amount is from a bank loan with a balance just over \$6.0 million. We do have pledge commitments yet to receive of about \$5.2 million, but more donations and early pledge payments will be needed to limit interest expenses and allow the school to move toward starting the next phase of construction, a Worship Arts facility.

More than thirty years ago, a group of supporters of CWC and Randolph Christian established a Foundation to provide for the ongoing needs and long term stability of our Christian schools. Through estate gifts, planned giving, life insurance policies, memorials, and direct donations, these funds are managed by the Foundation Board and through the efforts of the Barnabas Foundation. A percentage of these funds are returned to the schools each year in their budgets, while the remainder continue to grow through investments.

The Foundation financials were up last year – as the foundation ended the calendar year with \$1.14 Million in total assets and net income was \$79,000 for the fiscal year. Our annual return was 8.96% for the year which we are very happy with.

Our goals continue to be raising awareness of the foundation to our society to help ensure the long term outlook for Christian education, and also to help our society and parents in their wills and estate planning. We feel that we are still in the "building block" stages of what the Foundation can achieve. One of our main goals is to raise awareness of the Foundation to the Society Members of CWC and RCS. The Foundation offers scholarships, helps lower tuition costs, and helps with needs of both CWC and RCS.
