2025/26 Budget Narrative

CWC anticipates to break-even for the 2025–2026 school year as revenues and expenses remain aligned with budgeted projections. The Finance Committee, with special thanks to Lexy Medema and Chris Gann, has prepared a budget for 2026–2027 that highlights continued enrollment growth. The budget includes a 3% increase in teacher and staff salaries per the recommendation of our friends at CSI (Christian Schools International). Additional money is being contributed toward the building improvement fund as repairs and replacements become more prevalent and increases in administrative expenses are due to the upcoming accreditation in Fall 2026 and movement of subscription services to the operating budget. Teaching staff expenses are reduced for the coming year as costs are being transferred to Federal Title Funds. Revenue is expected to grow even as tuition rates remain unchanged for 2026–2027. This is due to the increasing number of total students at CWC as well as an increased number of students enrolled in the Wisconsin Choice program.

We are blessed to enjoy a time of continued growth along with effective financial management to ensure the continued success of CWC.

More than thirty years ago, a group of supporters of CWC and Randolph Christian established a Foundation to provide for the ongoing needs and long term stability of our Christian schools. Through estate gifts, planned giving, life insurance policies, memorials, and direct donations, these funds are managed by the Foundation Board and through the efforts of the Barnabas Foundation. A percentage of these funds are returned to the schools each year in their budgets, while the remainder continue to grow through investments.

The Foundation financials were up last year - as the foundation ended the calendar year with \$1.3 Million in total assets and net income was a little over \$111,000 with unrealized gains of \$109,000. For the April 1, 2025 - Dec. 31, 2025 time frame, our annual return was approximately 9.3% for the nine months, which we are very happy with.

Our goals continue to be raising awareness of the foundation to our society to help ensure the long term outlook for Christian education, and also to help our society and parents in their wills and estate planning. We feel that we are still in the "building block" stages of what the Foundation can achieve. One of our main goals is to raise awareness of the Foundation to the Society Members of CWC and RCS. The Foundation offers scholarships, helps lower tuition costs, and helps with needs of both CWC and RCS.

We will be having Will Planning meetings and an event in the fall to celebrate the Foundation. If you have any questions please feel free to reach out to any of the foundation board members or to Grace Bruins in the Advancement Office. We will be happy to set up a meeting with Barnabas - the organization that oversees our funds and are the experts on estate planning. Their consulting services to you are available at no cost to members of our constituency. These can be especially advantageous to you from a stewardship and taxation standpoint as you prepare for retirement, the transfer of land/business assets, and more. Together we can grow generosity and stewardship as we plan for the future today.
